From Mid-March 2020, many higher education institutes and schools across Australia had to move to remote (online) teaching. - How has wellbeing been impacted by the shift to blended modes of teaching and assessment?

- What levels of confidence and self-efficacy do music teachers demonstrate using different technologies?

You are not obliged to complete all questions; if you do not wish to respond to a particular question please leave it blank. The questionnaire will take between 15-20 minutes to complete. At the commencement of the online survey you will be asked to give your consent as a participant. Your involvement does not require your name or workplace. This ensures anonymity. Once you submit the survey it won't be possible to withdraw your data as it cannot be identified as connected to you.

There are no known risks associated with this study. You will be able to complete the online survey on your own device at your leisure. As this is a voluntary survey, you are not compelled to participate in the research if you feel unable to do so at this time.
